## RETIREE CERTIFICATION OF FIREARMS RANGE QUALIFICATION

### MONTEBELLO POLICE DEPARTMENT - RETIREE QUALIFICATION COURSE

The Montebello Police Department utilizes the Basic California P.O.S.T. 832p.c. Firearms qualification requirements for all retirees:

**Course Description:**

A daylight exercise test that requires the retiree to fire a minimum of 36 rounds and obtain a passing score as established by California POST on a handgun course consisting a B27 single target.

Twelve rounds shall be fired from a distance of three yards in 30 seconds, twelve rounds shall be fired from a distance of seven yards in 30 seconds, and twelve rounds shall be fired from a distance of fifteen yards in 45 seconds.

During the course(s) of fire the retiree is required to clear any malfunction that occurs, load and reload the handgun using the loading device authorized by the presenter. The retiree will safely demonstrate the following principles of handgun shooting:

1. Stance
2. Grip
3. Holster to stance/presentation
4. Breath control
5. Sight alignment
6. Trigger control
7. Follow-through

B-27 Target (max point X= 10 pts.)

Maximum Score 360 pts. (10 pts x 36 rounds)

80% (Passing Score) 288 pts.
